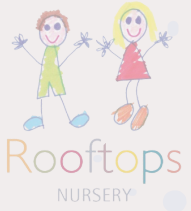

WELCOME TO OUR FESTIVE DECEMBER NEWSLETTER

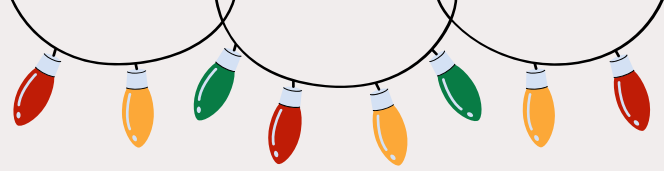
We can't believe it is the end of 2024!

FEE'S & FUNDING

This is just a little reminder that from January 2025 our fees are changing! Price lists have been sent out twice via EYlog so please make sure you've had a look at this as invoices for January have already been sent out. We also wanted to highlight for our parents that our minimum requirement of sessions is 2 full days and by September 2025 all children will be required to attend for the minimum. We are also planning to phase out half day sessions by September 2025.

We have been so lucky to have lots of families entitled to the government funding, but please can we also ask that parents remember to renew their funding codes every 3 months, and any new parents please ensure you get those codes across to us and fill out your funding loop forms as soon as you can!

TAX FREE CHILDCARE!

We wanted to reach out to our families and remind those of you who aren't taking advantage of the tax free childcare that you may be eligible for it! After having conversations with a few parents we realised that some families weren't aware you can use this account alongside your funding!

As you are aware, in the half terms you are required to pay full price for your childcare costs. We advise that parents who have access to a tax free childcare account add a little more than is needed each month for your fees into the account and let this build with the government top up and then you can use this to help cover the costs of your fees during the holidays! If you aren't sure if you qualify for the tax free childcare, please pop across to the childcare choices website and use their eligibility checker.
